Designetics, Inc., develops and manufactures industrial fluid applicators and fluid applicator systems designed for adhesive applications, manual fluid applicators, liquid dispensers, applicator brushes and closed-loop end-to-end fluid applicator systems. This letter is to confirm that the products provided by Designetics, Inc., have been evaluated against California proposition 65.

Proposition 65 (Safe Drinking Water and Toxic Enforcement Act of 1986) is a Californian law that requires business to notify Californians about significant chemicals that cause cancer or birth defects or other reproductive harm. The law requires that no person doing business, knowingly and intentionally expose an individual to a chemical known to the state of California to cause cancer, birth defects, or reproductive toxicity without first giving a clear and reasonable warning.

Designetics has reviewed and considered the substance list of the California Proposition 65 regulation. Having evaluated supplier certifications and material composition declarations, Designetics has determined, to the best of its knowledge and belief, that only the products listed below in Table 1, contain brass (which contains Lead). Lead is one of the substances listed on the California Proposition 65 List, published on December 29, 2023. The product numbers listed in Table 1, have a small brass piece associated with them, and the brass contains between 2.5-3.0% lead (CAS# 7439-92-1). Lead made the Proposition 65 list on February 27, 1987, due to its effect on both male and female development.

There are other chemical substances contained in select Designetics products that are also on the California Proposition 65 list, but these substances are not present in the context regulated by Proposition 65.

- Carbon Black (applies if airborne and unbound in products)
- Titanium Dioxide (applies if airborne, unbound particles of respirable size)
- Titanium* (applies if airborne and unbound in product)
- Chromium* (applies to hexavalent compounds only)
- Cobalt* (applies in powder form only)
- Vanadium* (applies if in crystalline form)
- Sulfur* (not applicable in stainless steel)

**Indicates the substance is contained only in stainless steel*
